# IHRC NIGERIA: A PRELUDE TO AFRICA'S COOPERATION AND REFORMS FOR ECONOMIC DEVELOPMENT AND INCLUSIVE LEADERSHIP THAT REPRESENTS AFRICA

The International Human Rights Commission (IHRC) under the absolute leadership of Secretary-General Prof h.c. Rafal Marcin Wasik is headed in Nigeria by H.E. Ambassador Dr. Duru Hezekiah. Ambassador Duru Hezekiah was officially appointed on the 16th of September 2022 after a comprehensive and legitimate background check on him came out clean. Before his official appointment, he was Acting Head of Mission IHRC Nigeria from April to September.

The International Human Rights Commission - IHRC is a Diplomatic Transnational Intergovernmental Organization and member of the "Migration and Home Affairs" Department of the European Commission, the executive and civil service of the European Union. An experienced, highly specialized peace negotiator and humanitarian aid provider; a self-financed, neutral, impartial, and independent organization with world headquarters in Zurich Geneva and Nigeria Office at 9 Cotonou Crescent Wuse Zone 6 FCT Abuja.

Dr. Duru Hezekiah was appointed the Ambassador at Large and Head of Diplomatic Mission IHRC Nigeria to uphold trust, foster collaboration, negotiate and resolve conflicts, and influence positive outcomes both in humanitarian interventions and advocacy between the Transnational Intergovernmental Organization- IHRC and the Federal Republic of Nigeria.

Upon his assumption of office in 2022, he has engendered cooperation and reforms that spur Economic Development and Inclusive Leadership, an undaunted apperception in the history of IHRC in the Africa Continent.

A full list of antecedents will prove to be too extensive. However, I must constrain myself with the bare minimum. IHRC Nigeria, a Prelude to Africa's Cooperation and Reforms for Economic Development and Inclusive Leadership that Represents Africa is generally attributed in recognition of the unwavering commitments of H.E. Ambassador Dr Duru Hezekiah to the International Human Rights Commission.

# 1. Securing of Office

While IHRC Nigeria Central Office was located at 12 Oke Agbe Street in Garki Abuja, a restricted apartment for carrying out the day-to-day activities of IHRC, reducing and berating our global identity. Against this background, H.E. Dr. Duru upon assumption of office with the knowledge of the IHRC Diplomatic Mission to Nigeria, identified the

undeserving environment and single-handedly sponsored the acquisition of a new office for IHRC Nigeria which has now relocated to 9 Cotonou Crescent Wuse Zone 6 FCT Abuja. The office is said to be a 5 bedroom Duplex, having two administrative parlors, 200 seater Capacity Conference Hall and well equipped with office facilities including technology and uninterrupted power supply

2. Improving Operations, Reducing Burnout

To improve the day-to-day activities of the Organization and as well reduce burnout, H E. Dr. Duru employed not less than 12 staff who are directly responsible for carrying out activities of the Organization.

3. IHRC First Assembly

Since the inception of IHRC in Nigeria, there has been little recognition of the Organization including affairs of the Special Monitoring Mission. Many State Zonal Volunteers Coordinators (ZVC) are not identified with the Central Office either, hence, a central control of activities and records of human rights abuses tends to be low until September 21st, 2022 where ZVCs across the Country were invited to the Central Office Abuja, for the First Assembly of IHRC members in Nigeria.

The meeting was an avenue to introduce H.E. Ambassador Dr. Duru Hezekiah at the new IHRC Ambassador at Large in Nigeria, familiarize and acquaint themselves with the scope of work and objectives of the International Human Rights Commission, and to present a strategic roadmap in moving forward.

# 4. Comprehensive Security Cooperation and Reforms

In commemoration of the September 21st International Day of Peace, in the heel of insecurity, insurgency, banditry, and diversity in Nigeria, H.E. Dr. Duru implored the Federal Government of Nigeria on the need for a peaceful dialogue with agitators as a means of restoring normalcy and reinstating inclusiveness in the Nigerian society.

### 5. Humanitarian and Disaster Interventions

The 2022 flooding experienced in Nigeria was intense and has been confirmed as Nigeria's worst flood disaster in a decade, and it was said to be worse than those of 2012 and 2018. IHRC Nigeria did not leave affected Nigerians during this devastating situation, but carried out participatory and damage assessment advocacy visits to some affected areas to





enhance national and global efforts in mitigating the flooding effects on Nigerians.

### 9. International Human Rights Day 2022

IHRC observed that the situation had pushed so many vibrant youths into seeking greener pastures abroad, a situation that has led to a brain drain in the country.

IHRC's Ambassador at Large and Head Diplomatic Mission, H.E. Ambassador Dr. Duru Hezekiah, who spoke during the 2022 universal declaration of Human Rights in Abuja, wondered why a country like Kenya could be enjoying constant power and Nigeria is groping in the dark despite its sufficient natural resources.

# 12. 2023 Election: IHRC Signs MOU with IPAC, Nigeria

Ahead of the 2023 general elections in Nigeria, the International Human Rights Commission, IHRC, under the watch of H.E. H.E. Ambassador Dr. Duru Hezekiah had 2022 sworn a general affidavit of disclaimer at the High Court of Justice in Maitama Abuja on the 18th of January, 2023.
